### **Haulers Helping the Homeless**

Starting in August, people in Lincoln will be able to help the poor and help the environment at the same time by giving clothing and shoes to their garbage haulers.

Through Haulers Helping the Homeless, the city's refuse haulers will start picking up bagged clothing, shoes, purses, belts and other textiles at the curb for residential customers.

The donations will go to the People's City Mission, and will be sold on the secondary market to

raise money for the mission's homeless program.

The program allows people to help the homeless and reduce the amount of material going to the landfill.

Individual refuse companies will notify their customers about the program and how they will handle pickup.

# New Nebraska Recycling Study is Topic of WasteCap Nebraska Meeting July 23 in Omaha
