### The Recycling Revolution

Communities across Nebraska and Cities through the U.S. and the world are adopting Zero Waste plans to drastically reduce what ends up in their landfills. They understand that after Reduce and Reuse, Recycling is one of the most important parts of a Zero Waste plan.

Recycling has been around for a long time. It has always made sense to use materials again rather than having to find new ones. It is only in recent years, since the costs of making stuff has become very low, that we have forgotten our long held American values of thriftiness and efficiency.

Concerns about how much trash we produce, and what to do with it all, have fueled the recycling

market in the U.S. Over the last 20 years, the national recycling rate has more than doubled, and now sits around 35%. We lag behind Germany and Austria who recycle over 60% of their discards. New sorting technologies are making recycling more efficient. Recycling facilities can now take more materials with less labor.

Manufacturers are finding new uses for recycled stock. It takes much less energy, and water, to make a product from recycled materials than from virgin stock, and it's less expensive. It's also better to recycle stuff into higher value products, like Spotaski Plastics in Nebraska, which makes plastic fence posts from milk jugs. This "upcycling" is preferred to "downcycling", in which the end product holds less value, like crushing glass into sand. By recycling materials into their highest possible use, like making old bottles into new ones, we can keep those materials out of the landfill longer.

According to the EPA, one of the best things we can do for people and the planet is to recycle. We can think of recycling as a "homegrown jobs, environmental and water program" all in one.

## Community Composting Training

WasteCap received a Public Information and Education grant from the Nebraska Environmental Trust to fund our **advanced composter training** starting July. The goal is to train community-level composters, for low-tech composting that does not rely on big equipment, but is larger in scale than a backyard operation. We are focusing on community gardeners and small scale vegetable farms around the Lincoln area.



WasteCap teamed up with the [Institute for Local Self Reliance](#) out of D.C. They have collected information about composter certification programs from around the country, and have created with a training manual that draws lessons of the best programs. We have partnered with Community CROPS and the Nebraska Extension office for co-organizing and teaching. The course includes 30 hours of classroom and field instruction, a bin build, and demonstrated ability to keep a pile for several months after the course ends in order to receive certification. Class size is limited, so participants must have access to a community-level pile site and have the ability to teach others.
