B Lab Announces B Corp Best for the World List

In early April, [Forbes](#) magazine featured a story on B Lab's annual release of the "B Corp Best for the World" list of honorees. Companies on this list are recognized for using the power of business to create positive social and environmental impacts, and have earned an overall score in the top 10% of all Certified B Corporations on the B Impact Assessment.

WasteCap Nebraska partners with B Lab by sharing a portal to their [Quick Impact Assessment](#) (a shorter version of the B Impact Assessment) on our web site. It's a quick and easy way to see how your company stacks up against the more than 20,000 other businesses that have taken the assessment, and discover areas for improvement. WasteCap also

provides follow-up support through green team training, waste assessments and more.

Also in April... Etsy, the online craft bazaar and certified B Corporation, made its debut on the Nasdaq stock market, closing at almost twice their initial public offering price. This was a milestone for the B Corp movement, as Etsy is only the second certified B Corp to go public. B Lab was founded as a nonprofit organization in 2006 has a vision that one day all companies will strive to be best *for* the world and create lasting value for all stakeholders.




